Description of first aid measures

General advice

Consult a physician. Show this safety data sheet to the doctor in attendance. Move out of dangerous area.

If inhaled

If breathed in, move person into fresh. If not breathing, give artificial respiration. Consult a physician after significant exposure.

In case of skin contact

Take off contaminated clothing and shoes immediately. Wash off with soap and plenty of water. Consult a physician. Immediate medical treatment is necessary as untreated wounds from corrosion of the skin heal slowly and with difficulty.

In case of eye contact

Rinse thoroughly with plenty of water for at least 15 minutes and consult a physician. Continue rinsing eyes during transport to hospital. Get medical attention immediately. Continue to rinse during transport of patient. Remove contact lenses. Protect unharmed eye. Keep eye wide open while rinsing. Small amounts splashed into eyes can cause irreversible tissue damage and blindness.

If swallowed

Do NOT induce vomiting. Never give anything by mouth to an unconscious person. Rinse mouth with water and drink plenty of water afterward. Take victim immediately to hospital. May cause chemical burns in mouth and throat.
