## Section 6: Accidental Release Measures

### Personal precautions, protective equipment and emergency procedures

## Section 7: Handling and Storage

### Precautions for safe handling

Avoid inhalation of vapor or mist. Keep away from sources of ignition-No smoking. Take measure to prevent the buildup of electrostatic charge.

Keep container tightly closed in a dry and well ventilated place. Containers which are opened must be carefully resealed and kept upright to prevent leakage.

### Exposure controls

#### Appropriate engineering controls

Handle in accordance with good industrial hygiene and safety practice. Wash hands before breaks and at the end of workday.

### Personal protective equipment

#### Eye/face protection

Safety glasses with side shields conforming to EN166. Use equipment for eye protection tested and approved under appropriate government standards such as NIOSH (US) or EN 166(EU).

#### Skin protection

Handle with gloves. Gloves must be inspected prior to use. Use proper glove removal technique (without touching glove's outer surface) to avoid skin contact with this product. Dispose of contaminated gloves after use in accordance with applicable laws and good laboratory practices. Wash and dry hands.

#### Body Protection

Impermeable clothing. Flame retardant antistatic protective clothing. The type of protective equipment must be selected according to the concentration and amount of the dangerous substance at the specific workplace.

#### Respiratory protection
